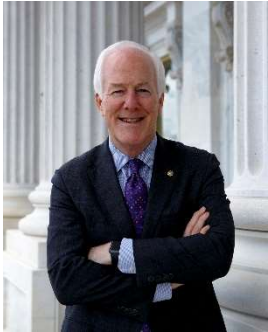

The Honorable John Cornyn



In 2020, Texans overwhelmingly re-elected Senator John Cornyn to represent them for a fourth term in the U.S. Senate. Since he was first elected in 2002, Sen. Cornyn has earned a national reputation as an articulate and powerful voice for Texas and conservative values in Washington. Sen. Cornyn, a San Antonio native, strongly believes that we need more Texas solutions in Washington, which is why he consistently fights to bring the Lone Star State's commonsense solutions to the federal level.

He has committed himself to strengthening our national defense, securing our borders, repairing our broken immigration system, and strengthening the economy by keeping taxes low, reducing federal spending, and fighting job-killing regulations from Washington bureaucrats. Sen. Cornyn has also been a tireless advocate for Texas military personnel, veterans, and their families, and he has fought to provide these brave Americans with the best possible support, care, and benefits.

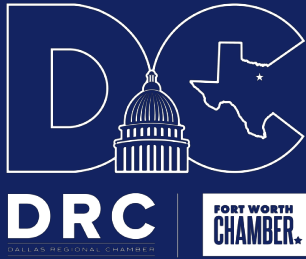
Sen. Cornyn serves on the Senate Finance, Intelligence, and Judiciary Committees, where he helps craft legislation on behalf of 29 million Texans. From 2013 until 2018, Sen. Cornyn was chosen by his colleagues to serve as the Whip, the second-highest ranking position in the Senate Republican Conference.

Sen. Cornyn has served the people of Texas for nearly four decades, first as a district judge and later as a member of the Texas Supreme Court and Texas Attorney General. He received his undergraduate degree from Trinity University, his law degree from St. Mary's School of Law, and his LLM from the University of Virginia Law School.

Sen. Cornyn married his wife Sandy in 1979, and they have two grown daughters.

The Honorable Ted Cruz



Ted, his wife Heidi, their two daughters Caroline and Catherine, and his entire family have been blessed to live the American Dream—the idea that anyone, through hard work and determination, can achieve anything. Ted is committed to ensuring every family has that same opportunity.

Ted grew up in Texas. His father, Rafael, fled Cuba after being tortured and imprisoned and came to Texas with just \$100 sewn into his underwear. Rafael got a job washing dishes, making 50 cents an hour, and learned English. He worked hard and attended the University of Texas at Austin, earning a degree in mathematics. He later started a small business in the oil and gas industry. Today, Rafael is a pastor in Dallas. Ted's mother, Eleanor, was born in Delaware to an Irish and Italian working-class family. She became the first in her family to go to college, graduating from Rice University with a degree in mathematics. She broke boundaries at Shell as one of the few women working as a computer programmer at the dawn of the computer age.

Ted earned his undergraduate degree from Princeton and his law degree from Harvard Law School. After law school, Ted clerked for Chief Justice Rehnquist and then worked in private practice. In 1999, Ted joined George W. Bush's campaign for president as a domestic policy advisor. The best thing about Ted's experience on the Bush-Cheney campaign, by far, was meeting Heidi Nelson, who also worked on the policy team. Heidi and Ted married after the campaign.

After working at the Department of Justice and the Federal Trade Commission during the Bush administration, Ted moved back home to be the Solicitor General of Texas. As Solicitor General, Ted argued eight cases before the Supreme Court of the United States and defended our freedom of speech, our right to keep and bear arms, and our religious liberty in courts across the nation. Following his service as Solicitor General, Ted returned to private practice, where he continued to litigate high-stakes cases and argued his ninth case before the Supreme Court. Ted and Heidi also started their family, welcoming Caroline and Catherine.

In 2013, Ted was sworn into the United States Senate, where he has been a passionate fighter for limited government, economic growth, and national security. He has authored dozens of legislative measures that have been signed into law, including expanding 529 college savings accounts to allow parents to save for K-12 public, private, and religious education, repealing Obamacare's individual mandate, imposing sanctions on terrorists who use civilians as human shields, designating North Korea as a state sponsor of terrorism, targeting Putin's Nord Stream 2 pipeline through multiple bills that halted construction and kept it stalled, reauthorizing and reforming NASA, holding dictatorships in South America accountable, and ensuring the availability of additional records to help solve civil rights cold cases. He is also leading the fight in the Senate to support Texas jobs, rein in Big Tech, secure the

border, and fundamentally reassess the U.S.-China relationship and hold the Chinese Communist Party accountable for covering up the coronavirus pandemic, committing human rights atrocities, and engaging in censorship, propaganda, and espionage in the United States.

The Honorable Kay Granger (TX-12)



A leader in national defense and global security, Kay Granger serves and fights for the 12th congressional district of Texas, which includes most of Parker County and the western half of Tarrant County. Since making history in 1997 as the first Republican woman to represent Texas in the U.S. House of Representatives, Granger has earned her reputation in Congress as an influential conservative leader.

In 2022, Granger was elected by her colleagues to serve as the Chairman of the powerful House Appropriations Committee in the 118th Congress. As the Committee's Lead Republican since 2019, Granger advocates for Republican priorities and fiscal responsibility – while working closely with House leadership, the Senate, and the White House to ensure that the needs of the American people are properly funded and met.

Granger was previously the first Republican woman to sit on the Defense Appropriations Subcommittee and went on to serve as the Chairwoman of the powerful subcommittee, which accounts for the majority of all federal funding appropriated by the Committee. As Chairwoman, Granger's priorities were bolstering America's military, supporting our service members and their families, and reversing harmful, arbitrary budget cuts to our national defense. She also previously served as the Chairwoman of the State and Foreign Operations Subcommittee, insisting on transparency in the State Department and diplomatic community, including in the probe into the attack on the U.S. diplomatic compound in Benghazi.

Granger has received many honors for her unshakeable commitment to our military and to restoring America's strength and power in the world. In 2020, she was awarded the U.S. National Guard Association's Harry S. Truman Award, the Association's highest honor. She has also received the Navy Distinguished Public Service Award and the Department of the Army's Decoration for Distinguished Civilian Service, the top civilian honors respectively bestowed by the Secretaries of the Navy and the Army. Granger is proud to use her knowledge of national security and appropriations to secure funding vital to not only our common defense but also the North Texas defense industry and the tens of

thousands of hardworking Texans who make the Fort Worth metroplex America's top defense industrial hub.

A native Texan, Granger knows firsthand how crucial it is to secure our Southern border from cartels and cross-border crimes. Granger has visited the U.S.-Mexico border many times to oversee the efforts of federal, state, and local law enforcement agencies. For her specialized expertise in border and immigration issues, she was selected to lead the special task force addressing the 2014 crisis when 60,000 migrant children were displaced along the Southern border.

Because of her commitment to a strong U.S.-Israel relationship, Granger played a key role in funding the current Memorandum of Understanding between the U.S. and Israel, which has allowed cooperation between our countries to reach unprecedented heights.

Granger has also been recognized for her strong support of NASA and U.S. dominance in the highest domain. She is a champion of NASA's *Artemis* program, which aims to land the first woman on the Moon by 2024. She urged the creation of the U.S. Space Force and U.S. Space Command, and fiercely advocates on behalf of Texas' longstanding role at the center of America's great space program.

Granger is an inductee of the Texas Women's Hall of Fame and the Fort Worth Business Hall of Fame, and she has received the Texas Association of Business' Bob Bolen Champion of Free Enterprise Lifetime Achievement Award and the Texas Wesleyan University's Law Sone Medal. In 2020, Granger's office was recognized by the Congressional Management Foundation with the Democracy Award, the premier accolade for Congressional offices demonstrating excellence in constituent services.

She is a member of the Council on Foreign Relations, sits on the Board of Directors of the International Republican Institute and Southwestern University, and is on the Board of Trustees for the Harry S. Truman Scholarship Foundation.

A lifelong resident of Fort Worth, Granger attended local public schools and graduated from Texas Wesleyan University. The powerful example set by her mother, a longtime principal in the Birdville Independent School District, instilled in her the importance of giving back to the community. Granger began her professional life following her mother's advice and following in her footsteps, teaching high school journalism and English at Richland High School. Later, as the owner of a successful small business, she entered public service to address issues impacting her community. Granger served as the Chair of the Fort Worth Zoning Commission, then was elected to the City Council—and in 1991, she was elected the first female Mayor of Fort Worth. In her five-year tenure as Mayor, Granger oversaw a period of rapid economic growth and led innovative crime-fighting reforms that slashed crime across the city by about 50%. Her success as Mayor was recognized when Fort Worth received the coveted All-America City Award from the National Civic League. Granger also led the successful crusade to preserve Fort Worth's military base installation through establishing America's first-ever Joint Reserve Base.

The Honorable Roger Williams (TX-25)



Roger Williams represents the 25th congressional district of Texas which is located in North Texas and stretches from Tarrant County in the east to Callahan County in the west. Williams was raised in the Fort Worth area and attended Texas Christian University, where he was an All-Southwest Conference baseball player and named to TCU's All-Decade Team for the 1960s.

Upon graduating, Williams was drafted by the Atlanta Braves and played in their farm system for many years before deciding to begin a new career as a small business owner and the head baseball coach at TCU.

His love of sports has followed Congressman Williams to the Capitol, where he is the chair of the bipartisan Congressional Baseball Caucus and the College Football Caucus. He is also the coach and manager of the Republican Congressional Baseball Team.

Williams was appointed by Governor Rick Perry in 2005 to serve as Texas Secretary of State where he helped usher in unprecedented economic growth to the state. He also served as the state's Chief Liaison for the Texas Border and Mexican Affairs.

In 2012, Williams was elected to Congress and has been the voice for Main Street America and families across the country. For over 50 years, he has run a family-owned car dealership and calf-cow operation. His real-world business experience has made him an effective leader and legislator. In the 118th Congress, Congressman Williams is proud to be the Chairman of the House Small Business Committee and serve on the House Financial Services Committee.

Williams is one of the few business owners in Congress and understands first-hand the effects of increased taxes, government regulation, and bureaucracy that hurt small businesses and economic growth. He stays focused on issues ranging from government deregulation, fiscal conservatism, helping struggling businesses recover from the government-mandated COVID-19 lockdowns, and more. As a legislator, he continues to prioritize his seven pillars: lower taxes, less governance, cutting spending, defending our borders, listening to our generals, understanding the 10th Amendment, and always standing with Israel.

The Honorable Pete Sessions (TX-17)



Pete Sessions believes the United States of America is the greatest country on Earth and is a strong advocate for civility among our elected officials. As a member of the 118th Congress, Pete is a voice of balance, reason, and common sense.

A native of Waco, Texas, Pete attended local public schools until the ninth grade. His father, Judge William Sessions, led a successful career as a Federal District Judge and was appointed to serve as the fourth Director of the Federal Bureau of Investigation under President Ronald Reagan. His father's leadership instilled Pete with a sense of duty and integrity for elected and non-elected public roles.

Pete attended Winston Churchill High School in San Antonio. Afterward, he graduated from Southwestern University in 1978. After college, he began working for the Southwestern Bell Telephone Company. Over his 16-year career, Pete never missed a day of work before retiring as District Manager.

He was first elected to Congress in 1996. Throughout his 24 years in Congress, Pete has been an integral player within the Republican Party. He spent a decade in Republican Party leadership and was instrumental in the House Majority balancing the federal budget from 1998 to 2001. Pete was Chairman of the National Republican Congressional Committee from 2009 through 2012, leading to a net 63-seat victory in 2010. From 2013 to 2019, Congressman Sessions served as Chairman of the House Committee on Rules, where he revived bipartisan efforts and accelerated the Republican agenda in the House of Representatives. He is currently a senior Member on the House Financial Services Committee and is the Chairman of the House Oversight and Accountability Subcommittee on Government Operations and the Federal Workforce.

No member of the Texas delegation has passed more legislation on the floor than Congressman Sessions. Notably, he sponsored and passed the Border Tunnel Task Force Act in 2018 to create a directorate to intercept illegal tunneling operations on the southern border. One of Pete's key accomplishments was sponsoring and passing the Family Opportunity Act of 2005, which enables families of medically stressed children to receive comprehensive healthcare. The bill became law in 2006 after Congressman Sessions and his son Alex worked with President Bush.

Pete has always valued community involvement throughout his life. He, his father, and his two sons are Eagle Scouts. Over the years, he has served in various leadership roles with the Boy Scouts of America, and disability assistance and local conservation groups. He also devoted twelve years to serving on the Board of Trustees at his alma mater, Southwestern University.

Congressman Sessions lives in Waco, Texas, and is married to Karen Sessions. They are the proud parents of five sons. Bill and his wife Kayle are both doctors living in Austin, Texas. Alex is a special-needs young man who works for Home Depot in Austin. Conor is a U.S. Navy veteran. Liam, a 2020 graduate of Baylor University, lives in Florida. Nicholas is a senior at Rollins College and a member of his college golf team.

The Honorable Marc Veasey (TX-33)



Rep. Veasey is an advocate for Texas' middle-class families and is committed to creating jobs, improving public education, fighting for immigration reform, and ensuring access to quality healthcare and women's reproductive rights.

Congressman Veasey was appointed in the 118th Congress to serve on the Energy and Commerce and House Armed Services Committees. Prior to his committee appointment, Rep. Veasey served on the Small Business Committee, and the Committee on Science, Space, and Technology.

Throughout his time in Congress, Rep. Veasey founded the first Congressional Voting Rights Caucus to address the immediate need to eliminate the barriers and discrimination too many Americans face at the polls. In the 117th Congress, he accepted his appointment as an Assistant and Regional Whip. In the 118th Congress, the Congressman was appointed to serve as a Whip for the Gun Violence Prevention Taskforce.

Rep. Veasey is currently a member of the U.S. Helsinki Commission, the Congressional Black Caucus, and the New Democrat Coalition. He also co-launched the Blue Collar Caucus with Congressman Brendan Boyle to find solutions to problems too many middle-class Americans are facing. The Blue Collar Caucus supports unions and focuses on addressing wage stagnation, offshoring, and job insecurity for those in the manufacturing and building trades.

First elected to the Texas State House in 2004, Congressman Veasey represented District 95 – an area now part of the 33rd Congressional District. As a member of the Texas State House, Rep. Veasey served in a number of leadership positions, including Democratic Whip and Chair of the Democratic Caucus.

Issues he championed included fighting for affordable healthcare, funding for better schools, and advocating for a livable wage. Prior to serving four terms in the Texas House of Representatives, Rep. Veasey worked as a congressional staffer in North Texas for Congressman Martin Frost.

As a Representative, Colin is dedicated to helping North Texas families gain the same opportunities he had to fulfill his dreams. Colin's top priorities in Congress are working to lower health care costs, protecting Medicare and Social Security, and creating an economy that works for everyone. Colin is passionate about expanding access to vocational and trade schools and lowering the cost of college, so all North Texans have a shot at a middle-class job. He believes Congress must find common ground to rebuild our aging roads and bridges, pass comprehensive immigration reform, and take care of our veterans.

The Honorable Jake Ellzey (TX-6)



Congressman Jake Ellzey proudly serves the 6th Congressional District of Texas, encompassing all of Ellis, Navarro, Anderson, Hill, Cherokee, and parts of Tarrant, Dallas, Freestone, and Johnson counties.

During his first term in office, Jake committed himself to improving the quality and care we give those who have served in our nation's military. Through his work on the VA Committee during the 117th Congress, he passed the VITAL Assessment Act and the Major Medical Facilities Authorization Act, helping to expand support for veterans in Texas and around the United States. On January 7, Jake was sworn into his second term in the House of Representatives. In the 118th Congress, he serves on the House Appropriations Committee, which is responsible for the allocation of taxpayer dollars. Jake was appointed to work on the Commerce, Justice, Science and Related Agencies, the Labor, Health and Human Services, Education, and the Interior, Environment, and Related Agencies subcommittees, which oversee six of the fifteen executive departments. Jake also serves on the Committee for Small Business.

After graduating from the Naval Academy, Jake went on to serve his country for 20 years as a helicopter pilot and as a fighter pilot in F-14s and F/A-18s. He concluded his military service as the Air Boss on the U.S.S. Ronald Reagan aircraft carrier. During his career, Jake was deployed nine times, with five combat tours, including a ground tour in support of SEAL Team 5 in Iraq.

After retiring from the military, Jake was a military contractor in Afghanistan, a small business owner, a commercial airline pilot, a Commissioner of the Texas Veterans Commission, and served as a Texas State Representative in the 10th district of Texas.

Jake was born in Perrytown, Texas, and raised on the LZ family ranch. For over a decade, he and his wife, Shelby, have been raising their two children in Ellis County.

Congressman Pat Fallon has represented North Texans in the Texas Legislature since 2013 and proudly serves today as the Congressman for Texas' Fourth Congressional District, where he serves over 700,000 great Americans. Congressman Fallon is currently a member of the House Armed Services Committee, the Cyber, Information Technologies, and Innovation subcommittee, and the Tactical Air and Land Forces subcommittee. He also serves on the House Oversight and Accountability Committee, as the Chairman of the Energy Policy, Economic Growth, and Regulatory Affairs, and on the National Security, the Border, and Foreign Affairs subcommittee.

Prior to his time in the Texas Senate and House, Pat enjoyed a decades-long successful entrepreneurial career, having founded over a dozen successful companies.

To raise funds and awareness for pediatric cancer research, Pat entered what has been billed as “the world’s greatest endurance challenge” in 2016. He completed the World Marathon Challenge, a race where competitors attempt to run 7 marathons on 7 continents in 7 days, on January 29, 2016, becoming just the 15th person in the world to do so successfully. He was also the first (and still only) person to finish the World Marathon Challenge with no previous marathon experience.

Congressman Fallon is a proud graduate of the University of Notre Dame, where he played varsity football under legendary coach Lou Holtz and was a member of the 1988 National Championship team. Upon graduation, Pat received a commission to serve as an officer in the United States Air Force, where he was stationed at Sheppard Air Force Base in Wichita Falls, TX.

Pat has been happily married to his lovely wife, Susan, for 19 years, and they have two boys, Thomas (16) and Mac (13).

The Honorable Beth Van Duyne (TX-24)



Congresswoman Beth Van Duyne proudly represents the 24th Congressional District of Texas, which includes portions of Dallas and Tarrant counties. Cities which are wholly or partially included in the 24th District include Addison, Bedford, Carrollton, Colleyville, Coppell, Dallas, Euless, Farmers Branch, Flower Mound, Fort Worth, Grapevine, Haltom City, Hurst, Irving, Keller, Lewisville, North Richland Hills, Richardson, Roanoke, Southlake, Trophy Club, Watauga, and Westlake. The DFW International Airport, of which Beth is a former board member, is centrally located in the heart of the district.

Now in her second term, Beth was selected to serve on the powerful House Ways and Means Committee, which is responsible for initiating tax and financial policies. Assigned to the Taxation and Oversight Subcommittees, Beth is focused on delivering solutions to help individuals keep more of what they earn, allow businesses to expand operations and compete in globally competitive markets, and hold administration policies and management accountable for actions detrimental to U.S. economic expansion and growing prosperity for our families. As a Texan, Beth is particularly interested in fostering policies that will empower our country with an abundant, affordable, and reliable energy supply to lower costs for families and deliver the power needed for our nation to enjoy an expansion of U.S.-based manufacturing.

Beth was also chosen to serve as Chair of the House Small Business Subcommittee on Oversight, where she concentrates on policies to encourage workforce development, labor participation, and reviews administration actions directly related to the health and well-being of American small businesses.

Prior to being elected to Congress, Beth served as Regional Administrator for the U.S. Department of Housing and Urban Development (HUD), Mayor of Irving, Irving City Council Member, and a businesswoman. In 2017, Beth was appointed to serve as the Regional Administrator for the U.S. Department of Housing and Urban Development's Southwest Region. Working under Secretary Ben Carson, Beth was tasked with overseeing HUD programs and operations in the Region's five states of Arkansas, Louisiana, New Mexico, Oklahoma, and Texas, where she worked on many of the Trump Administration's proudest economic successes, such as opportunity zones, and led HUD's disaster recovery efforts at the southwest border in the aftermath of Hurricane Harvey.

Before being named Administrator, Beth was the first woman elected to serve as the Mayor of Irving from 2011 to 2017 after beginning her career in public service as an Irving City Council Representative from 2004 to 2010. Under her leadership, the City of Irving witnessed unprecedented economic growth and development with an added 40,000 jobs and an estimated \$3 billion in growth and new developments, while also being named the fifth safest city in America.

Throughout Beth's career, she has worked with small startup companies, mid-size private companies, and Fortune 500 corporations alike. Beth also ran a consulting business where she helped executives develop strategic business plans, negotiation strategies, grassroots coalition building, and federal and state legislative policy strategies.

After graduating magna cum laude from Cornell University, Beth moved back to Irving, Texas, which has been her home for over 30 years. Proud mother to Katie and Pearce, Beth was only the second Republican woman from Texas to be elected to the U.S. House of Representatives.

The Honorable Jasmine Crockett (TX-30)



Congresswoman Jasmine Crockett has purposefully made every decision with one goal in mind: protecting the civil liberties of those in underrepresented communities. As a public defender, civil rights attorney, State Representative, and United States Congresswoman, Jasmine Crockett dedicates her life to public service, with the goal of serving justice and ensuring equality for all.

In the midst of political turmoil, economic distress, and racial inequality, Congresswoman Crockett laced up her shoes to march for justice and run for the Texas House of Representatives. The sole Black freshman and youngest Black lawmaker in Texas during the 87th Legislative Session, Congresswoman Crockett navigated what has been marked as the most conservative session in Texas

history. Despite the uphill climb, Congresswoman Crockett filed more bills than any other freshman, assembled a wide coalition to pass landmark criminal justice reforms in the House, and brought more accessibility and accountability to her office than ever before. She was a founding member of both the Texas Progressive Caucus as well as the Texas Caucus on Climate, Energy, and the Environment. As a State Representative, she fought for economic opportunity as a member of the Business & Industry Committee and advocated for reform on the Criminal Jurisprudence Committee. Congresswoman Crockett was one of the lead architects of the 2021 Texas House Quorum Break, which brought attention to the draconian and restrictive voting measures being proposed in the legislature.

Her passion for justice and the protection of peoples' rights led her to pursue a career as a public defender and civil rights and criminal defense attorney. She focused on defending the most vulnerable among us from exploitation in the criminal justice system. As she began her career in the Bowie County Public Defender's Office, Congresswoman Crockett worked tirelessly to keep children safe and out of jail. Her time there serves as a reminder that criminal justice is an intersectional issue.

Following her service in the Texas Legislature, Congresswoman Crockett accepted the call and won the election for retiring Chairwoman Eddie Bernice Johnson's congressional seat in Texas' 30th District. Following her election, she hit the ground running and won a seat at the Leadership table as Freshman Leadership Representative, a position she will use to advocate for all Texans. As Freshman Leadership Representative, she is one of a few Black women ever elected to Democratic House Leadership. The Honorable Nathaniel Moran (TX-1)



Nathaniel Moran became a Texan just a few months before he turned two years old when his parents moved to rural East Texas with other families of faith to help start a small Bible College in southern Smith County. His formative years were spent growing up in a single-wide trailer home on that Bible College campus, where he learned from his parents the values of hard work, service to others, and service to God. Nathaniel spent most of his childhood exploring the woods around the Bible College, riding bikes on bumpy county roads, and shooting snakes with his BB gun along the West Mud Creek. Nathaniel and his family eventually moved to Whitehouse, Texas, where Nathaniel attended Whitehouse I.S.D. and graduated in 1993, proudly serving as Senior Class President and Captain of the Wildcat football team. It was during Nathaniel's fourth grade year at Whitehouse that a love for public service rooted itself in his heart, as he—guided by his father—closely followed Ronald Reagan's bid for re-election as President. To this day, Nathaniel considers himself to be a Reagan

Republican whose conservative values were shaped primarily by his father, President Reagan's service, and by the strong, steady voice of Rush Limbaugh over the talk radio air waves for more than two decades.

After high school, Nathaniel attended the United States Military Academy at West Point for two years before transferring to Texas Tech University, where he ultimately earned a B.A. in Russian Language and Area Studies, an MBA, and a law degree. It was at Texas Tech that Nathaniel also met Kyna, whom he married just one week before starting law school. Upon graduation from law school, Kyna and Nathaniel moved to Tyler, where Nathaniel began practicing law and Kyna began teaching elementary school. For the past two decades, Nathaniel's civil law practice has focused primarily on business and commercial litigation and transaction work. Nathaniel and Kyna have now been married for over twenty-three years and they have four school-aged children, who serve as a primary motivation for his service in Congress.

Nathaniel began his elected public service as a member of the City Council for the City of Tyler, Texas from 2005-2009. In 2009, just after being re-elected to his third term on the Tyler City Council, Nathaniel was appointed as Mayor Pro Tem, but resigned immediately to move his family to Houston, Texas for three years so that his oldest son could attend a specialized school for the Deaf. The unexpected opportunity to relocate his family for this purpose led to the miracle of his son learning to speak by age seven, something they did not think was possible. Upon returning to Tyler, Nathaniel returned to the practice of law and began giving back to his community through service with numerous non-profit organizations, including the Boy Scouts of America, the Discovery Science Place, Cancer Foundation for Life, and Tyler Area Chamber of Commerce. He also helped start an education foundation for Whitehouse I.S.D. At varying times over the past two decades, he has also been a Sunday School teacher, church deacon, trombone player for the church worship team, and coach of his daughters' basketball teams.

In 2016, Nathaniel was appointed as the Smith County Judge to fill a vacancy in that position. As Smith County Judge, Nathaniel served as the presiding officer of the Commissioners Court, Chief Budget Officer, judge of the Constitutional County Court (which had original jurisdiction over probate, guardianship, and civil mental health matters), chair of the Juvenile Board, head of emergency management, and chief administrative officer of the County. In 2018, he was elected to a full four-year term as County Judge and he continued in that role until he was elected to Congress in November 2022. Because of his work in the area of mental health, Nathaniel was appointed to the Texas Judicial Commission on Mental Health in 2021. Nathaniel is proud of his decades of volunteer and elected service to his community and looks forward to continuing to fulfill this calling of service in Congress. Ultimately, Nathaniel seeks to fulfill the Great Commandment found in Matthew 22: 36-40.
