The office also actively supports local nonprofits, including Mosaic Family Services, which serves refugees and others in crisis, and Dallas Life, a homeless service provider, demonstrating B&T's dedication to giving back and making a positive local impact.

"We know Texas well, as many of our clients call Texas home or have operations in the state. Our lawyers in Dallas represent these companies across the country and around the world," said Haskins. "We established an office identity over 10 years that mirrors the firm's — relentlessly fight for your clients."

The Dallas office's culture of entrepreneurship and client commitment has also created a thriving workplace environment. B&T's Dallas office earned a "Best Place to Work" award from the Dallas Business Journal in 2019, only four years after it opened. More recently, the Dallas Regional Chamber presented the firm with its inaugural "Best Place for Working Parents® Dallas Innovator Award," celebrating practices that nurture work-life balance and support working parents.
